**Delivery:**

- Deliver artwork and completed entry form to CFAC in Rock Springs by Friday, September 29, 2017 at 5:00 p.m.
- The show will end November 2nd. Work should be picked up as soon as possible after that day.

**Guidelines:**

- This exhibit will hang in the CFAC which is a department of the Sweetwater County Library System and should conform with community standards in regard to subject matter (i.e.. no violence, erotica ).
- Work can be no larger than 8 square feet. *All work will be framed appropriately and ready to hang with framing wire. 3D works must sit on a stable base or easily hung.*
- Attach an information card (in this prospectus) securely to the back of each work. Copies can be made of these cards.
