### GUIDELINES:

- This exhibit will hang in the White Mountain Library which is a department of the Sweetwater County Library System, and should conform with community standards in regards to subject matter (i.e. no violence, erotica)
- Work can be no larger than 8 square feet.
- **All work must be gallery ready and hung with framing wire.**
- Attach information card (in this prospectus) securely to the back of each work. Copies can be made of these cards.
